

Horicon Bank's Paycheck Protection Program (PPP) Information Sheet for Sole Proprietorship, Independent Contractor or Self-Employed:

The following will be needed to be presented along with your application to Horicon Bank:

- 1. Individuals must submit documentation to establish eligibility such as:
 - a. 2019 and/or 2020 Payroll Records
 - b. 2019 and/or 2020 Payroll Tax Filings
 - c. 2019 and/or 2020 Form 1099-Misc.
 - d. 2019 Tax Returns (2020 if completed)
- 2. Documentation reflecting the health insurance premiums paid.
- 3. Documentation of all retirement plans paid.
- 4. Only Computer Driven Documentation is acceptable. Not hand written.

Once completed, please contact your business lender at Horicon Bank.

*Due to the large volume of SBA application, Horicon Bank is only accepting current business clients.

Applications will be processed in the order that they are received, and can only be processed once they are fully completed and necessary supporting documentation is received. Please note that funds are limited and subject to approval from the SBA.
